

Entry Form and Regulations for **Showtime at the Boykin**

- All participants must be students currently enrolled at a public school, private school, home school, or charter school in Wilson/Wilson County.
 - Exception: Vocal entries may use one pre-approved, adult or Wilson County student as an instrumental accompanist.
 - Vocalist may not be considered as an accompanist.
- All contestants must print out all song lyrics to any song that will be used during the performance. This must be included with the entry form.
- Contestants can only be in one judged act as a performer.
- A judged performer in a judged act may be in another act only as an accompanist.
- Talent acts may only be 2.5 minutes in length.
 - An official timekeeper will time each act.
 - One point will be deducted from each judge's score for every five seconds you go over the 2.5 minute time limit.
- No video, PowerPoint, or DVD may be used as part of an act.
- No lip-synching is allowed. Singers using CD's must eliminate voices as in a karaoke track.
- **DEADLINE FOR ENTRIES IS APRIL 18TH AT 5:00 PM**
- Entry forms can be found on the Arts Council of Wilson's website (wilsonarts.com), picked up at the Arts Council of Wilson, or from the Performing Arts Director Christopher Ballance at the Arts Council.
- A non-refundable entry fee of \$20 for each act must accompany each entry.
- No late entries will be accepted
- Each entry will be subject to approval by the Performing Arts Director of the Arts Council of Wilson.
- 15 entries from the K-5 category will be selected
- 15 entries from the 6-8 category will be selected
- 15 entries from the 9-12 category will be selected
- If more entries are received, auditions will be held on April 24th and 25th at 5:30 pm at the Arts Council of Wilson to pare each category down to 15 entries.
- Each category will be awarded a 1st, 2nd, and 3rd place prize.
- Rehearsals will be held the week of the talent show. Times will be assigned for your rehearsal. **YOU WILL NOT BE ALLOWED TO PERFORM IF YOU DO NOT COME FOR YOUR ASSIGNED REHEARSAL TIME.**
